RESOLUTION OF THE VENTURA LOCAL AGENCY FORMATION COMMISSION INITIATING PROCEEDINGS FOR THE DISSOLUTION OF THE LAKE SHERWOOD COMMUNITY SERVICES DISTRICT

WHEREAS, the Commission desires to initiate a proposal pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (§ 56000 et seq. of the California Government Code) for the dissolution of the Lake Sherwood Community Services District (LSCSD); and

WHEREAS, initiation of the dissolution of the LSCSD was duly considered on November 15, 2023; and

WHEREAS, the Commission heard, discussed and considered all oral and written testimony for and against the initiation of the dissolution including, but not limited to, the LAFCo Staff Report including the staff recommendation; and

WHEREAS, on October 23, 2023, the State Controller published a list of special districts considered to be inactive as defined in Government Code § 56042; and

WHEREAS, the LSCSD is included in the list and is an inactive district pursuant to Government Code § 56042; and

WHEREAS, the State Controller notified LAFCo of the LSCSD's inclusion on the list; and WHEREAS, the Commission is required, pursuant to Government Code § 56879, to initiate dissolution of inactive districts within 90 days of receiving notification from the State Controller, unless the Commission determines that the district does not meet the criteria set forth in Government Code § 56042.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the Ventura Local Agency Formation Commission as follows:

- (1) The LAFCo Staff Report dated November 15, 2023, and recommendation to initiate the dissolution of the LSCSD are adopted.
- (2) The LSCSD meets the criteria of an inactive district pursuant to Government Code § 56042.
- (3) Dissolution proceedings are hereby initiated for the LSCSD, the boundaries of which are generally depicted in Exhibit A attached.

- (4) The subject dissolution is assigned the following distinctive short form designation: LAFCO 23-25 LAKE SHERWOOD COMMUNITY SERVICES DISTRICT DISSOLUTION.
- (5) The Commission shall hold a public hearing to consider the dissolution of the LSCSD within 90 days of the date this resolution is adopted, pursuant to Government Code § 56879.



WHEREAS, on October 23, 2023, the State Controller published a list of special districts considered to be inactive as defined in Government Code § 56042; and

WHEREAS, the Lake Sherwood Community Services District (LSCSD) is included in the list and is an inactive district pursuant to Government Code § 56042; and

WHEREAS, the State Controller notified LAFCo of LSCSD's inclusion on the list; and WHEREAS, the Commission is required, pursuant to Government Code § 56879, to initiate dissolution of inactive districts within 90 days of receiving notification from the State Controller, unless the Commission determines that the district does not meet the criteria set forth in Government Code § 56042; and

WHEREAS, on November 15, 2023, the Commission determined that the LSCSD meets the definition of an inactive district, and adopted LAFCo Resolution 23-25A initiating dissolution proceedings for the LSCSD; and

WHEREAS, the Commission is required, pursuant to Government Code § 56879, to hold one public hearing on the dissolution of an inactive district no more than 90 days following adoption of the resolution initiating dissolution; and

WHEREAS, notice was provided at the times and in the manner required by law; and WHEREAS, the proposal was duly considered on February 21, 2024; and

WHEREAS, the Commission heard and considered all oral and written testimony for and against the proposal including, but not limited to, the LAFCo Staff Report including the staff recommendation.

NOW, THEREFORE, BE IT RESOLVED, DETERMINED AND ORDERED by the Ventura Local Agency Formation Commission as follows:

(1) The LAFCo Staff Report dated February 21, 2024, and recommendation for approval of the proposal are adopted.

- (2) The dissolution of the LSCSD, the boundaries of which are generally depicted in Exhibit A (attached), is hereby approved.
- The subject proposal is assigned the following distinctive short form designation: LAFCO
 23-25 LAKE SHERWOOD COMMUNITY SERVICES DISTRICT DISSOLUTION.
- (4) Pending the issuance and recordation of a Certificate of Completion, the LSCSD shall not: (1) appropriate, encumber, expend, or otherwise obligate, any revenue of the LSCSD, or (2) hire any staff or contractors.
- (5) Upon the effective date of the dissolution (i.e., recordation of the Certificate of Completion), the LSCSD shall be dissolved, its existence shall be terminated, and all of its powers shall cease.

This resolution was adopted on February 21, 2024.


