#### **LAFCo 25-06S Ojai Valley Sanitary District Sphere of Influence Amendment 790 & 792 Baldwin Road**

**Project Description:** The project includes an amendment to the Ojai Valley Sanitary District (OVSD) sphere of influence boundary, which would enable the annexation of territory (i.e., Assessor's Parcel Number (APN) 032-0-010-040) to the OVSD. The sphere of influence amendment request is associated with the proposal for annexation of the same territory to the OVSD (LAFCo 25-06).
